## XIII.Closing Worship

#### Rules Of Procedure

"Robert's Rules of Order shall prevail at the Annual Meeting."

Constitution of the West Stafford Church, Art. XII., Sect. B, Item 1h.

#### From "Robert's Rules of Order":

Following the Agenda:

"If it is desired to transact business out of its order, it is necessary to suspend the rules, which can

be done by a two-thirds vote."

Conducting Business:

"Before any subject is open to debate it is necessary, first, that a motion be made by a member

who has obtained the floor; second, that it be seconded; and third, that it be stated by the

moderator."

Debate:

"Each member has the right to speak twice on the same question ... but cannot make a second speech on the same question as long as any member who has not spoken on that question desires

the floor. Debate must be limited to the merits of the immediately pending questions."

The Previous Question:

"The form of this motion is, 'I move the previous question!'. As it cannot be debated or amended, it must be voted on immediately ... the effect of ordering the previous question is to close debate immediately, and to bring the assembly at once to a vote on the immediately pending question."

General Consent:

"Business can be expedited greatly by avoiding the formality of motions and voting in routine

business and on questions of routine importance, the chair assuming general consent until

someone objects."

Voting by Ballot:

"Where the by-laws do not require the vote to be by ballot, it can be so ordered by majority vote,

or by general consent."

Acceptance of Reports:

"If the report contains only a statement of fact for the information of the assembly, the reporting member makes no motion its disposal, as there is no necessity for action on the report. But, if any action is taken, the proper motion, which should be made by someone else, is to accept the report which has the effect of endorsing the report and making the assembly assume responsibility for a lift it is a financial report ... and when the auditing committee reports, this report should be accepted, which carries with it the endorsement of the financial report. If the report contains

recommendations ... the proper motion is to adopt the recommendations."

To Defer Action:

(a)Postpone to a Certain Time. If it is desired to defer action upon a question till a particular time,

the proper motion to make is "to postpone it to that time." (b) Lay on the Table. Instead of postponing a question to a particular time, it may be desired to lay it aside temporarily until some other question is disposed of, retaining the privilege of resuming its consideration at any time.

The only way to accomplish this is to move that the question "lie on the table".

Recommended by the Conference Parliamentarian:

Amendments in Writing:

Members proposing amendments to motions, resolutions, reports, or recommendations shall submit the amendments in writing to the clerk at the time the amendment is moved.

Diane Hassman made a motion to remove the above members to inactive status and it was seconded by Ken May. After an explanation of the reasoning behind this transaction, the action was approved by a vote.

B. Vote to accept Karen Hatch's request to be removed from membership.

Ken May made a motion to remove Karen Hatch from the membership list and it was seconded by Ruthanne Talamini and approved by a vote.

- C. Trustee's Report on Investment Committee, discussion and vote on recommendations. Ross Kerr made a presentation on behalf of Trustees and explained that Current investment strategy involved low interest and we were in danger of falling behind. The committee recommended investing approximately 18% of the unrestricted funds, \$18,000, in three good mutual funds on a dollar cost averaging basis. \$1500 would be transferred per month, 500 into each fund. After discussion a motion was made by Richard Passmore and seconded by Ralph Winn to accept the recommendation. The action was passed with a unanimous vote.
- D. Trustee's Report on Long Range Planning Committee, recommendations, discussion and vote on recommendations based upon building inspector's findings at the parish house.

Ross Kerr made a presentation on behalf of the Trustees. Ross explained that the inspection revealed that the following work needed to be done in 1997:

- 1. replace sills
- 2. replace garage floor
- 3. improve the drainage around the garage
- 4. replace floor support under the kitchen and front office

Items 1 through 3 would be done by Ralph Winn and other members and the fourth would be put out to bid.

Items to be covered beyond the 1997 time frame are additional parking, reopen the balcony, pew seat cushions, better lighting, remodel the kitchen, additional storage, handicapped access, update electric system, improve the parish house.

Ken May motioned and Richard Passmore seconded that the recommendations be accepted and a unanimous vote was made approving the action.

E. Honoring Seventy and Eighty year members:

Rev. Wadsworth spoke giving appropriate remarks honoring Emerson Davis, Myron Davis and Beatrice Cady and presented them with plaques. James Tripoli was also honored with a certificate of appreciation for his five years of music ministry.

F. Report on Renovations of meeting house including Financial Repayment, and discussion and vote on plan to rededicate the meeting house.

Rev. Wadsworth acknowledged the business involving renovations of the meeting house had already been taken care of. Rev. Wadsworth spoke about all the accomplishments that have been made in the last four years and that it was a credit to the membership. He commented that even people around town have made comment about our buildings and that something good must be happening here. He proposed it was time to have a rededication of the church. Ruthanne Talamini made a motion that it be held on October 26, 1997 to coincide with the church anniversary. Joe Demars seconded it and it was approved by vote.

G. New Business from the floor:

The moderator raised the topic of coffee hour and that some people expressed the feeling it would be better to limit coffee hour to just coffee so that there was no pressure to provide baked goods. Discussion from the floor indicated the current way of holding coffee hour was fine. There is no requirement to have baked goods. If you want to provide them it is okay.

The meeting was adjourned at 3:20 PM

For Second Congregational Church, 1997 has been the busiest and most involved year on record, at least as far as I have seen or have read about. For your pastor, personally, administratively and professionally 1997 has to be one for the recordbooks and I believe that without your prayers and support it may have proven impossible at times.

The loss of my father this past spring was a sad chapter for me personally. I shall miss him. My faith assures me he is at peace after his long illness. 1997 began with me throwing out my back and having to deal with that over the next couple of months. Negotiating the pulpit area fully robed and with crutches must have seemed humorous. As always some of you volunteered to pitch in and added to your own load without being asked. "Thank you" seems barely adequate.

The complete destruction of my office in the west wing of the Parish House was my next surprising challenge of note. According to some that may have heard the impact of the vehicle, I had been out of my office only 40 min. or so. To be specific only 8 days before Easter a (nice new) pickup truck impaled itself into my office, making what organization I had prepared for Holy Week a moot point. For a time I shifted my organizational base to the old secretary's office with part of my files in various caches throughout the house and upstairs while plans and arrangements for repairs were being made over the spring and summer. I eventually moved into my present office which was the old library/classroom.

Concurrently on Easter morning, after four hours away at services I returned home to a flooded kitchen and home office. Constantly running hot water had "rained" into the entire quadrant of the basement where my research office was located, saturating furniture, books, rugs, etc. That debacle took several months to right as well.

This was, as a result, a year of huge challenges. It was also a year of huge changes and global projects for our church family. The impact of the truck created the necessity for a decision to be made concerning the Parish House as a structure thus forcing the Long Range Planning Committee and Trustees to work in close and sometimes overlapping parallel scenarios for a time. The result of this were two church meetings in the late springtime whereby votes were taken to repair and renovate the parish house structure over time and to create a parking lot (temporary) upon the to-be-purchased neighboring land. To date we can be proud of the brand new replaced wing on the parish house and a regularly filled parking lot although it was sad to have to level the old home on that land. (The addition of the existing storage barn was a clear aid for future storage needs.) These events remain significant because they place us upon a track to improve our facilities and our capability to minister to more of our community. The expected placement of a traffic stoplight by the State at the intersection in front of the church will soon provide a solution to the long range problem of the dangerous exit (or entry) from church grounds from any egress point. I look forward to its instillation eagerly.

To keep tabs on all of the situations and events administratively has been challenging. Due to the shifting of the office several times and the moving away of our historian to name a couple the level of paperwork has increased quite a bit. Even so, I find I am able timewise to keep up with what is needed to be done. Of note though, as this increases, we will have a need for a secretary simply for the filing and correspondence. Within that vein I give a special thanks to my wife Robin who continued to decipher my handwriting and do the bulletins for the year. Additional thanks to Ken May for his patience in teaching me WORD and later on ridding us of the virus that infected the computer and disks. I know I will continue to count on your counsel as we look forward into the creation of a webb site and other cyberspace items.

The resilience and hope of our church family was shown clearly this year within the cornucopia of activities, worship, outreach projects and special circumstances that arose. You rose to meet several challenges that we can be proud of. Last June we concluded our challenge food drive to "balance the scales" against the combined weight of Bruce Ladr, Larry Laudenslager and Rev. Wadsworth in which we together contributed 1200 pounds of food to the Stafford Food Bank over the previous nine months. Last Fall we celebrated the re-dedication of our meetinghouse which culminated the renovation work done a couple of years prior to that and supported by the congregation. We found that our computer equipment was

lacking in capability and with help and advice from several of our congregation we now have upgraded the system to handle more sophisticated software needed to integrate our operations more efficiently. In worship we find our sanctuary filling and the Sunday School highly attended. Our teachers, staff and substitutes are all to be credited with the strength of the mission. At Sun Valley this year, even though the service was delayed by a week, the attendance by number was recordmaking. Add to this a large number of new acolytes beginning our worship and the large number of children attending Silver Lake in the summer sessions and we find that we are working hard to try to integrate life, faith and living among the people we live with and serve. The greatest compliment I receive from you is your decision to bring relatives to church with you when they visit from afar, showing how proud you are to be a part of this church family.

Ecumenically we have continued the interaction with other churches. Baccalaureate services this year had record-setting attendance with over 115 people. During the week of prayer for Christian Unity I went to lead worship at the Stafford Baptist Church and this year (Jan, 1998) I will be participating in the 11:00 Mass at St. Edwards Roman Catholic Church. On Memorial Day it was an honor to gather with other civic groups to memorialize those who have died before us and later in the summer I led the dedication of a monument in commemoration of the Davis family in West Stafford during their 100th Reunion.

I am proud our church has continued to offer its facilities to community groups such as scouts, AA, the "Academy of Music" programs, CODA, the Birth to 3 Program to name a few. All these groups are designed to improve individuals' lives as well as their families' lives too. We support those groups that will endeavor to improve those who live in our communities. Within this outreach I must give Cindy Lingley a hearty thanks for she has continued to lead (with as much energy as they) our Youth Group. I also applaud our choir and its director Jim Tripoli. It is a wonderful problem that if the entire choir is in attendance it is impossible to logistically fit the group in the choir loft. Additional thanks to the Tripoli's for the production, replication and distribution of our newsletter. This is a massive job and one of great necessity for us as we move forward in many areas. A particular thanks this year to the Trustees and , in specific, Bill Gowdy for keeping a firm but compassionate hand on the process of lealing with insurance companies, contractors , town and church committees as various situations presented themselves and we endeavored to move forward with prudence and expedience.

So, as you can see our 233rd year has indeed been a challenging year and I have only hit the high points.

I have a few challenges to offer as we move towards this new year. First both leader and member need to take the time to be informed. There is and will continue to be a lot going on, some depending on the input of the congregation. Three informational areas exist: KIT, posted notices and verbal announcements at worship. I use all of these with practicality but I would press people to take the time/ opportunity to be informed about what is happening and what is needed. Second, I would like to see heightened participation in some of the mission and fundraising events. The motif of congregationalism is the participation of the people who are its members. The leadership needs many hands for the work that goes on here. This may be making ornaments for the next Bazaar or muffins for Easter breakfast. Some say they have never been asked. Consider yourself "asked". My final challenge this year is a challenge of mission. The final report of the Long Range Planning Committee suggests a mission activity involving all ages. I concur and challenge us to search out and embrace a mission project.

I close my report in thanksgiving for you in many ways. This church remains in my prayers as do its people and I count upon your prayers for me as I continue as your pastor. We still have a great deal to do but I feel assured that with God's help (as we have seen) even the surprising can be possible.

This year and for 1999 I offer as our text from Romans 12:4-13

"For as in one body we have many members, and all the members do not have the same function. So, we, though many are one body in Christ, and individually members one of another. Having gifts that differ according to the grace given to us, let us use them: if prophecy, in proportion to our faith; if service, in our serving; he who teaches, in his teaching; he who exhorts, in his exhortation; he who contributes, in liberality; he who gives aid, with zeal; he who does acts of mercy, with cheerfulness. Let love be genuine; hate what is evil, hold fast to what is good; love one another with brotherly affection; outdo one another in showing honor. Never flag in zeal, be aglow with the Spirit, serve the Lord. Rejoice in your hope, be patient in tribulation, be constant in prayer. Contribute to the needs of the saints, practice hospitality.

#### **Church Council**

The Church Council has had a momentous year in 1997. We have held nine regular council meetings and two special meetings in addition to the Annual Meeting in January. Following the incident where the truck hit the church prior to Palm Sunday, we struggled with the future of the physical plant and future growth for our congregation. With the Long Range Planning Committee hard at work preparing plans for the future expansion of the church, we were then faced with the immediate needs of the west wing of the parish house.

The first special congregational meeting on May 18th was focused on two issues:

- The purchase of the abutting property owned by John Kowalyshyn
- Directing the Long Range Planning Committee on a direction to pursue regarding the building/renovation of the parish house and the meeting house.

The results of the decisions were to purchase the property and to immediately set about investigating the repair/replacement of the west wing of the parish house in conjunction with the Board of Trustees.

The second congregational meeting on June 15th was dedicated to authorizing the money for the Board of Trustees to execute the replacement of the west wing and to install a gravel parking lot on the Kowalyshyn property. It has been very exciting to see the finished product of the parish house and to have the opportunity to alleviate the severe parking problem we have recently experienced.

This has been a year in which the council has worked very diligently to look to the future of our congregation while focusing on the ever-present need for stewardship of the assets of the church body. Heartfelt thanks are extended by me to all the members of the council who so faithfully attended the meetings and worked above and beyond the call of their jobs. Special kudos go to Bill Gowdy and the Board of Trustees for their total dedication to overseeing the building project so competently completed by Moulton Brothers. This massive project was faithfully superintended by Bill and his crew. Thank you all very much.

The Long Range Planning Committee has completed their work and submitted a proposed covenant to be accepted by the congregation at the annual meeting. Thank you to Ed Parker and the committee for their many meetings and the hard work they have done.

Last, but not least is a special thank you to Rev. Wadsworth for his dedication to the vision of our church body. We continue to be a church focused on trying to discern God's will for our congregation while using the polity of the democratic church our forefathers established for us many years ago. It has been my pleasure to serve as your moderator for the last two years. I wish Godspeed and the Lord's peace to each and every member of my church family as we journey in Christ's path.

# **Church Clerk**

This year was a little more active for the Clerk because of the activity centered around the Long Range Planning Committee and the Trustee's unexpected emergency renovations to the Parish House necessitated by the vehicular damage done to the building, both requiring Special Church Meetings in addition to the usual Annual Meeting and monthly Council meetings. Minutes have been prepared and are on file covering these meetings.

In addition, the Council asked that a study be conducted to see if there is a need to computerize the church records. With the help of Kim Kowalyshyn, Ass't Clerk, Dorrain Parker and Ken May a questionnaire was sent to all committee heads asking for their input. The resulting data was evaluated and it was determined a number of committees share the need for the same information and there is some duplication of effort in record keeping. It was concluded that there was a moderate need to computerize records after updating the church computer and then it should be done on a gradual basis, with provisions for training. More details are contained in the October report to Council.

#### **Trustees**

1997 was a challenging and at times a hectic year for the trustees. The following were the primary events for the year:

- Invested savings --Following a vote by the congregation at the January 1997 annual meeting, an investment committee
  was formed. This committee consisted of Bill Hassman, Ross Kerr, Joe Demars, Ralph Winn, Willard Gowdy and John
  Leavitt. During 1997 the committee invested \$15,000 into three mutual funds -- Fidelity Growth and Income, Vanguard
  Windsor II, and T. Rowe Price Equity.
- 2. Parish House Repairs In the fall of 1996 the trustees received from the Long Range Planning Committee, an engineers report detailing structure problems in the Parish House. It was the goal of the Trustees to correct as many of the problems as possible. In February the sills on the east end of the building were replaced and a new support column was installed to support the first floor. This work was done by Stone Depot. In March the west end of the Parish House was struck by a run away truck. Fortunately no one was hurt, however the damage to the building was extensive. After much work by the Long Range Planning Committee, the Trustees and the congregation, a meeting was held in June 1997. After a good debate it was voted to demolish the west end of the building and rebuild it. The new west wing contains a handicap accessible entry, handicap bathroom, small kitchen area, and a church library\meeting room. It also has a roughed in room on the second floor. This work was done by the Moulton Brothers construction. The work was completed in time for the opening of Sunday School in September. Of special note is all of the painting, staining, and clean up was done by members of the church. Without their help the job would not have been completed on time.
- 3. Land Purchase In the spring of 1997 John and Eleanor Kowalshyn informed the church of their interest in selling their property east of the church Parish House. Negotiations began immediately. The congregation voted to buy the property and construct a parking area. Property was purchased for \$75,000. Included in the purchase was a barn, a house, and approximately 2.5 acres of land. After careful inspection, it was determined that the house was beyond repair. With the

## Trustees (Con't)

help of the Town of Stafford the house was removed. A temporary parking area was put in by L.V. construction.

4. Following the land purchase, a loan of \$30,000 at 7% fixed for 15 years was procured at the Stafford Savings Bank. This loan helped us finish our many projects without having to take all our money out of investments.

In summary 1997 was exciting, tiring, and at times frustrating. We spent more money than any other year in our history. We also more than doubled our property holdings and in so doing will be able to meet future land needs of the Church. At the start of the year we began restoration work on a Parish House that had seen years of neglect. We finish the year with one third of the building brand new and plans in place to make the rest of the building as good as new. As I look back at 1997 I'm amazed at our many accomplishments.

I would like to thank all who helped throughout the year, many hands do make light work. Of special note was the superb secretarial work of Bill Hassman.

This year Joe was on vacation the first Sunday in August, so we moved the communion service at Sun Valley to the second Sunday. Attendance was quite large, with many visitors from the campground attending. Later that afternoon the church held its annual picnic. Coverage of Joe's vacation Sundays was provided by Rev. Melanie Enfield, Mrs. Jane Hooper and Mr. Richard Larson.

Diaconate has been busy with additional items that may be of interest. A presence on the World Wide Web is being worked on and should appear in early 1998. The new Diaconate will have a group of seven young people participating in confirmation. This should produce several new members of our congregation in the spring. Our campership fund just keeps getting larger each year. This fund provides early registration fees to ensure that our children have a good opportunity to get the conference of their choice, as well as providing scholarships for those children whose families would struggle to pay the camp fees. A new group of acolytes is participating in the morning worship, and two new robes have been ordered to augment the four that we have.

In summary, it has been a very busy year for the Deacons. We hope that our efforts have enhanced the overall worship experience for members of the congregation.

# **Long Range Planning Committee**

# An Eye to the Future

Formed in January 1996, the Long Range Planning Committee was charged by the Council to define and anticipate the needs of the Church over the next several years.

Realizing that the opinions of the whole church must be considered in this endeavor, various methods of gathering information were employed, the most successful of which was the Focus Groups. Loaded with ideas from a substantial percentage of the membership, the committee attempted to categorize and evaluate each and every suggestion. Certain items which could be addressed in a more short-term horizon were immediately referred to other boards and committees. Three items emerged as primary concerns to virtually everyone: inadequate parking space, the need for refurbishing or replacing the Parish House, and the need for an expanded Sanctuary and Fellowship Hall.

The committee explored a number of possible solutions to these issues, involving members of the Trustees, Diaconate, and Christian Ed. An architect was brought in to view the properties and make suggestions. Several members offered drawings and plans. During this period, two events occurred. First, when the Trustees (at the request of this committee) inquired about leasing space for parking from John Kowalyshyn, an attractive offer of sale was made for the entire property Second, the truck which damaged the west end of the Parish House served as a catalyst for prompt action on plans to renovate the building.

The congregation acted on these matters, and the Trustees assumed responsibility for the immediate projects; Council appointed a Building Committee to oversee the Parish House and Meeting House issues, and the committee was able to

# Long Range Planning Committee (Con't)

focus again on its original purpose: the establishment of two, five, and ten year goals. It is the belief of this committee that the items presented here reflect the needs expressed by the congregation, and that they are realistic and attainable. Therefore, the Long Range Planning Committee recommends the adoption of the following:

# By the end of two years

#### **PHYSICAL**

- Complete plans for renovation of the Parish House, expansion of the Sanctuary and Fellowship Hall, with particular attention to accessibility for the handicapped;
- Plan and initiate a capital fund drive to pay for the renovation and expansion projects.

#### **PROGRAM**

- To encourage an increase in membership of 5% annually;
- To encourage an increase in Sunday School population of 7% annually;
- To increase giving and decrease fund raising to meet the budget;
- To increase the volunteer base;
- To institute a Missions project which directly involves the membership (Habitat for Humanity, for example); this ideally includes both the youth and the adults;
- To develop adult Christian Education by establishing Retreat Weekend(s);
- To budget for and hire a secretary.

# By the end of five years

## **PHYSICAL**

- To complete work on the Parish House, and begin work on the Sanctuary and Fellowship Hall;
- To purchase a new organ as part of the Sanctuary expansion.

#### **PROGRAM**

- To continue growth objectives outlined above (membership and giving);
- To broaden the music program to include guest artists and a wider variety of worship music.

# By the end of ten years

## **PHYSICAL**

- To have completed all renovation projects;
- To have paid for all costs of renovations.

#### **PROGRAM**

- To maintain growth objectives, to the ultimate goal of covering the entire budget with giving, and eliminate fund raising for paying bills;
- To add a Youth Minister to the staff, possibly as a Christian Ed leader. This would be contingent on actual growth of the membership.

We believe that the Holy Spirit has been active with this committee, and will lead us as we covenant to adopt and achieve these goals.
