It has been my privilege to be your interim pastor for the past seven months. As you begin the task of searching for a new pastor, where will the journey take you? Hopefully you will find a pastor who is called by God and the church, and help you seek God's will for Second Congregational Church and that you will move faithfully and surely into the 21st century. I know you can do it because you are committed to and dedicated to see that this church will serve the next generation.

We are now in the process of organizing a Search Committee to find our new permanent minister.

Our thanks to Ken May for jumping in on the Clerk's work this past year and for doing all the copying and collating of the Annual Report.

#### **Church Clerk**

During the last eighteen months there has been a great amount of upheaval in the Church Clerk position. The Clerk at the beginning of the period was Suki Garrell. In February of 2011 a Church Meeting was held to vote on changes to the Church Constitution. The changes were approved, and the changes focused on two specific area of church life: the fiscal year was changed back to the calendar year with the Annual Meeting in late January; and, the Boards and Committees were reduced in size as well as the Church Council reduced in size. Due to the change in fiscal year, this period between Annual Meetings has stretched eighteen months.

There was further upheaval when our Clerk Suki Milan passed away unexpectantly in mid-year. It has been difficult to ensure that all Clerk records have been properly returned to the church.

#### **Trustees**

The church family has faced and handled numerous challenges over this period of time, first was the church steeple / cupola repairs paid for by the Church Steeple Fund (repaying loans from four members of the church one of the four has donated the money he had loaned.) While we have not yet reached the total needed we are on schedule to fulfill our commitments. We celebrated the steeple with a dedication ceremony on the churches birthday 10/31/2010.

The Trustees investigated options and decided to install a new concrete walk way in front of the parish house the total cost of this project was paid for by a generous member of the church.

In Dec. 2010 during a regular furnace cleaning it was discovered that the combustion chamber in the parish house furnace needed to be replaced, this project too was funded by a member of the church.

In Jan 2011 the furnace in the church was not working an emergency call was made and a transformer and primary control had to be replaced at the cost of \$500.00.

In order to raise awareness about our financial status the board asked the treasurer Ken to have monthly updates in each issue of KIT. The trustees concern of the draw of invested funds has prompted us to look into long range financial planning and we continue to investigate methods of securing the churches financial future such as an annuity plan offered by Prudential, ING or Wells Fargo. The financial arm of the UCC also has resources that we could employ. This investigation will continue. We are also doing "comparison shopping" for services we use such as our insurance coverage. We are comparing the coverage and price of our current provider to other companies in order to ensure we have the best coverage at the best cost.

The snowfall amounts of last winter caused multiple issues for the Trustees and the church members as a whole. The barn roof collapse and slippery conditions on our property necessitated two insurance claims. Also due to the severity of

the weather the bill for the plowing, shoveling and furnace repairs exceeded the budgeted amount so money had to be reallocated to meet obligations.

The spring brought more issues, there was no electricity on the second floor of the Sunday school building so an electrician was hired and we had to change a sub- service breaker. The Trustees performed a test of the fire alarms and emergency lighting and found some of the lights to be inoperable. We are working on replacement batteries / lights. The warm weather and spring rain highlighted the "pond" in our lower parking lot as well as the fact that low rider tractor trailer trucks were regularly using the lot to turn around in. The trucks being so low did a great deal of damage to the ground when they exited. Quality Paving Co. was contracted to put in two paved aprons and to add material to and level parking lot in order to eliminate the water issue. They also moved granite blocks to strategic locations in order to discourage trucks from turning around in the lot. To further discourage trucks the trustees installed a chain across one of the entrances to limit use. Quality Paving has finished the job and will evaluate the lot in the spring to see if any additional work needs to be done. A very generous member has offered to pay the \$3500.00 bill for this project.

In June the barn roof was completed and we laid plywood flooring on the upper level of the barn to minimize debris falling on the items in the lower level. It was arranged for the insurance co. to pay for repair of the grounds around the lower parking lot and barn that were dug up by heavy equipment used in the repair of the roof. It also covered additional cost of structural repairs as some beams supporting the upper level of the barn had to be repaired.

In the fall our frequently broken down copy machine was replaced with a new model and service contract. We also had to acquire a new water treatment system as the old one was not functioning and the water smelled and tasted terrible. Banner water was contracted and the system installed, the water is now free of odor and tastes fine. The cost of \$2100.00 has been covered by another generous church member. New lights for the barn have been donated and then installed by 3 members of the church. In addition the old knob and tube light fixtures have been removed and sold.

The Trustees have maintained the church property and overseen the church's finances and have successfully faced and handled issues and projects as they arose.

My heartfelt thanks to the members of the Board of Trustees for their dedication and hard work, it has been my pleasure to serve with you. Special thanks to our treasurer Ken May for managing all our accounts and budget preparation. Thanks also to the extremely generous members that have funded a number of the projects in this report. I offer my personal thanks to two former Trustee chairmen, Ross Kerr and Bill Gowdy for their support and guidance over the last 18 months.

The diaconate met a total of 13 times during this report period, flexing meeting times to accommodate the diaconate members' hectic schedules. This was often necessary in order to have all members present at meetings.

The Diaconate was faced with many challenges, most specifically being designated to search for the Interim Pastor following the retirement of Pastor Wayne Strevor. The Deacons approached this task prayerfully and with the guidance of Susan Torolli from the Conference, were blessed to find Stuart Charter who is the current Part time Interim Pastor.

During this period of the search for the Interim Pastor, the Diaconate took on the duties of ministering to the church with the leading of worship. Many thanks to all who led worship through readings and sermons during this time.

The acolyte program was less structured this year due to variables including the decrease in the number of children of age to participate. Despite this, there were still those in the congregation that consistently assisted with this very important aspect of our worship when the smaller children weren't present.

Due to the storm of the Century in October 2011, the service on the 30th was cancelled. Due to widespread power outages the cancellation couldn't be broadcasted on television.

Advent discussion in December of 2010 went well and the Christmas Eve services for 2010 and 2011 were at earlier times to appeal to families with small children. This seemed to be well received.

Beth Bolieau was welcomed as a new member of the church in July 2011.

Brookside service was in September 2011 and feedback was mixed due to the cooler but bright and sunny weather. We had a wonderful cookout following the service

September 11, 2011 service was a special service "A Litany of Remembrance, Penitence and Hope" in remembrance of 911.

Book discussion of Hotel on the Corner of Bitter and Sweet on November 10th, 2011 went well

Baptisms November, 2010 of Jacoby Joseph and June 2011 of Tyler Salisbury

Poinsettia and Easter Lilly sales continued as with tradition with proceeds going to the campership fund for Silver Lake.

Pastor Stuart has been working with Alaina Bolieau on her confirmation since September 2011

Madrigals came to the church on December 11, 2011 for a carol sing, enjoyed by all

Many thanks to the congregation as a whole for their support of the Diaconate and the many works that have been accomplished over this report period. # **Stewardship Committee**

We have been going along with the 2010 pledge agreements since we extended our year by 6 months from July 2011 thru Dec 2011. Most of the congregation agreed to the extension and continued with their 2010 pledge amounts. No formal letter was written regarding that extension but the request was given by word of mouth.

The pledge goal given to us by the treasurer was \$35,000. Although we did not meet that goal, we are grateful for the generosity of the congregation during these financially uncertain times.
